2008 Grantees Thoughtfully Determined

\$47,500 Awarded to 12 Non-Profits



After three meetings, ten hours and face-to-face presentations, numerous interviews, careful research, and systematic evaluation, your 2008 CWO Grants Committee determined 12 awardees for the proceeds of this year's fund-raising efforts. "It was the most thorough process we've ever undertaken," noted Committee Chair Brenda Manning. "We used multiple evaluation tools to increase validity and reliability, reduce subjectivity, and enhance the qualitative nature of our decisions."

Grant-making is an art and a science—and this year's Committee instituted new procedures that will make its grants even more impactful. Application forms were designed to cover 13 key areas for quantitative and qualitative review. A rating scale was developed for oral presentation evaluation. A grid was created to capture reviewers' impressions of request worth, clarity, feasibility, importance, need and humanitarian outreach.

After much deliberation, 12 organizations emerged from the 17, who had applied for CWO funding. They include: Carpe Diem Farms, Inc.; Community Care Clinic; Highlands-Cashiers Hospital Foundation; Highlands-Cashiers Land Trust; Highlands Community Child Development Center; Highlands Emergency Council; Highlands Historical Society; Hudson Library; International Friendship Center; Jackson-Macon Conservation Alliance; Performing Arts Center, Inc.; and The Bascom.



Interested in joining the Grants Committee in 2009? Contact President Colleen Flinn, or Brenda Manning. Next year, the Committee will expand to three task groups:

Task Group One: *Community Research Team* will solicit grant proposals and provide assistance and support for grant writing. The decision tools used this year will be available to all organizations wishing to apply for a grant—so they can better understand our process.

Task Group Two: *Decision Team* will decide who receives CWO funding, using the multiple methods, statistical measures, and qualitative tools described above.

Task Group Three: *Evaluation Team* will evaluate grant effectiveness as awardees' proposals are carried out, following-up with telephone interviews, reviewing of written reports and conducting site visits.


Gifts donated through CWO Charities' Donor-Advised Fund are 100% tax deductible and amplify impact of member donations.
